Sub: Complaint against Satvir Singh Advocate Enrollment No. P4135/2022, Mobile No. 98720-15860, and Deepinder Singh advocate, enrollment No. P2227/2016, Mobile No. 94785-27107 for misleading the courts by appearing in the courts as counsel for complainant as well as for accused and for giving false statements in the Hon'ble courts.

Sir,

It is respectfully submitted as under:

1. That Satvir Singh Advocate having enrollment No. **P4135/2022** and Deepinder Singh Advocate having enrollment No. **P2227/2016**, are real bothers and are misleading the courts by appearing himself as well as advocate of complainant as well as advocate of accused in the same case. The number of cases in which they make their presence on behalf of the complainant as well as on behalf of accused and in some cases one of the brother appeared before the Hon'ble courts as himself complainant and his brother Deepinder Singh appear as advocate for Satvir Singh (complainant) are as under:.

complainant/ plaintiff and on the other hand they represent them as accused in various courts

That both the above said advocates are making pick and choose target and are misleading the courts by representing themselves from both the parties likely plaintiff/ complainant and as advocates of accused and giving false statements in the Hon'ble courts. It is pertinent to mention here that both the above said advocates giving threats to the innocent peoples and thereafter file criminal complaints/ cases against them and afterwards affect compromise with them with an intention to grab money. Copies of the complaints moved/ filed by Satvir Singh and Deepinder Singh and compromises are attached herewith. Both the above said advocates also used to file complaints against the advocates before judicial officer. Thus their above said acts are against professional ethics and misconduct on their part with advocates and judicial officers also. It is worth mentioning here that CC No. 54/2019 disciplinary committee Bar Council of Punjab and Haryana, Chandigarh case title Vipin Sharma Versus Deepinder Singh Advocate one time practicing licence of Deepinder Singh has also been cancelled due to by making forged documents and ID cards of some persons namely Harbhajan Singh and giving surety to the Hon'ble court. Copy of the

said order is attached herewith and FIR No. 233 /2019 u/s 323, IPC and section 3 of SC&ST Act also got registered against both the accused Satvir Singh and Deepinder Singh, (copy attached). The above facts shows the criminal act and conduct and behavior of both the above said persons that they threatening the innocent people and they misleading the Hon'ble courts also by filing fake complaints against the innocent peoples

It is, therefore, respectfully prayed that their act and conduct is against the ethics of profession hence, necessary action may please be taken against both the above said advocates for misleading the courts and giving false statements in the Hon'ble courts.
