**Sub: Complaint against Satvir Singh Advocate
Enrollment No. P4135/2022, Mobile No. 98720-
15860, and Deepinder Singh advocate,
enrollment No. P2227/2016, Mobile No. 94785-
27107 for misleading the courts by appearing in
the courts as counsel for complainant as well as
for accused and for giving false statements in the
Hon'ble courts.**

Sir,

It is respectfully submitted as under:

1. That Satvir Singh Advocate having enrollment No. **P4135/2022** and Deepinder Singh Advocate having enrollment No. **P2227/2016**, are real brothers and are misleading the courts by appearing himself as well as advocate of complainant as well as advocate of accused in the same case. The number of cases in which they make their presence on behalf of the complainant as well as on behalf of accused and in some cases one of the brother appeared before the Hon'ble courts as himself complainant and his brother Deepinder Singh appear as advocate for Satvir Singh (complainant) are as under:.

- i) CRM 24/2024 pending in the court of Shri Rupinder Singh, Ld. Addl. CJM Hoshiarpur and CRM 23/2024 pending in the court of Ms. Rinky Agnihotri, Ld. JMIC Hoshiarpur, (copies attached), in which Satvir Singh appearing as advocate and Balwinder Singh appear through attorney as petitioner and in most of the cases Balwinder Singh is made as accused by Satvir Singh advocate and in the present case Balwinder Singh has been made as complainant by Satvir Singh.
- ii) Civil suit No. 116/2023 Garhshankar court, Hoshiarpur (copy attached), in which Satvir Singh advocate is plaintiff and Deepinder Singh is appeared as an advocate for the plaintiff and one Balwinder Singh is made one of the defendant/respondent and in CRM 327/2023 case titled Hitesh Kumar versus SHO Model Town, Hoshiarpur pending in the court of Ms. Sarabjit Kaur, Ld. JMIC Hoshiarpur,, (copy attached), in which Satvir Singh representing complainant as an advocate and this complaint is also against Balwinder Singh and others.
- iii) NACT 49/2023 pending in the court at Anandpur Sahib, (copy attached), in which Satvir Singh appeared as complainant and Balwinder Singh is made as accused in the said case and in FIR No. 122/2023, under sections 148, 149, 341, 342,

323, 506 IPC PS Anandpur Sahib got registered by complainant Satvir Singh against Balwinder Singh (copy attached). In this FIR Satvir Singh representing himself as complainant and Balwinder Singh as accused and Deepinder Singh appear before the Hon'ble court as an advocate.

- iv) CRR 115/2023 pending before the court of Mrs. Jaswinder Sheemar, Ld. Addl. Sessions Judge, Hoshiarpur, (copy attached), in which Satvir Singh is appearing as complainant and Deepinder Singh appearing as his counsel and this revision is also filed against the Balwinder Singh and others.
- v) In case FIR No. 94/2023, PS City, Hoshiarpur, under sections 420, 406 IPC Satvir Singh representing himself as complainant, (copy attached) and the trustee members namely Malkait Singh, and Surinder Singh are accused and now he made a compromise with Malkiat Singh and Surinder Singh and after getting attorney from accused Malkiat Singh and Surinder Singh in the name of Balwinder Singh, now Balwinder Singh has filed a case as complainant/ plaintiff against others. On one hand Satvir Singh and Deepinder Singh representing and used Balwinder Singh as
