**(Complaint U/S 156 (3) Crpc To Issue Directions To Register Fir Against The
Accused Number 01 To 05)**

Respectfully Showeth,

1. That The Complainant Is A Permanent Resident Of The Above Mentioned Address And A Responsible Citizen.the complainant is a practicing advocate in dist courts hoshiarpur.
2. That accused number 1 to 4 with above mentioned particulars are residents of dist. Hoshiarpur and have done the offence as belowmentioned within dist hoshiarpur.
3. That accused number 5 is a trust situated with abovementioned particulars having its trustees namely parvinder singh nijjar r.o village dianatpur ,near kathar and trustee at abovementioned address.malkiat singh s.o hari singh,surinder kaur w/o malkiat singh,onkar singh s/o hari singh,raminder saggoo all trustees at abovementioned address. Balwinder singh s/o sukhchain singh r/o village dadyal,saila khurd dist hoshiarpur is the manager at abovesaid trust looking after the affairs of the abovesaid trust in india.
4. That accused no. 1 to 4 have done offence by intentionally posting offensive material in social media against govt. of india.such posts are liked ,shared and commented by all accused no. 1 to 5 intentionally ,repeatedly and severally.these posts were made viral by all accused intentionally. The material posted by the accused is highly offensive in nature and challenges the sovereignty, integrity and security of the nation.
5. That The accused no. 1 namely Deepak chaudhary posted one content in social media on date 8 jan as the screenshot of the same is submitted with the present petition. Such post clearly shows that it is an anti national post which is circulated by the accused with intent to defame govt of india.it is against the sovereignty and integrity of the country. After accused no. 1 posted the material in social media /facebook ,all accused ranging from accused no. 1 to 5 made their efforts to make it viral.then they all liked, commented and shared such objectionable material against govt of india.
6. That afterwards one post is put on date 16 aug 2017 and screenshot for the same is submitted with petition.the said post is put by accused no 1 namely Deepak chaudhary and accused no. 4 namely sandeep kumar.it is a baseless post without any ground or evidences and it is against the security agencies of the country hence shows the bent of mind of the accused towards anti national powers.this post is again liked commented and shared by all accused no. 1 to 5.

7. That accused no. 4 namely sandeep kumar posted one post in social media/facebook on date 30 oct 2021. It is against the hon ble prime minister of india where extremely bad language is used by the accused .the post is highly offensive in nature .it is posted with an intent to spread rumours,it has defamed honble prime minister of india.the accused have thus done an offence of going against the interests of the state.
 8. That all other accused ranging from accused no. 1 to 5 made it viral and have liked, commented and shared the illegal material on facebook.
 9. That one illegal post dated 13july 2021 is shared by accused no. 4 namely sandeep kumar which is against govt of india and goes towards raising cyber terrorism.it is in form of one song against prime minister of india.again all accused as 1 to 5 have liked and shared it.
 10. That one illegal post dated 16 oct 2020 is shared by accused no. 4 namely sandeep kumar which is against govt of india and goes towards raising cyber terrorism.it is in form of one song against prime minister of india. again all accused as 1 to 5 have liked and shared it.
 11. That one illegal post dated 23 sep 2021 is shared by accused no. 4 namely sandeep kumar which is against govt of india and goes towards raising cyber terrorism.it is in form of one song against prime minister of india. again all accused as 1 to 5 have liked and shared it. This post is against sovereignty , safety & security of the nation. It tends towards disturbing foreign relation of the country.
 12. That one illegal post dated 21-apr-2021 & 15 may 2021 is shared by accused no. 4 namely sandeep kumar which is against govt of india and goes towards raising cyber terrorism.it is in form of one song against prime minister of india. again all accused as 1 to 5 have liked and shared it. This post is against sovereignty , safety & security of the nation..It tends towards disturbing foreign relation of the country.
 13. That similarly one more post is put by the accused namely sandeep kumar on date 09-11-2021 & 16-08-2017 which is highly offensive and anti national material is there.
 14. That several other posts are also put by the accused no- 01 to 05 on social media / facebook for which screen shots are being submitted . these posts are having anti-national meaning and go against the sovereignty of the country , hence these posts come under the definition of cyber terrorism.
 15. That one complaint was moved before the nri wing of the punjab police because the accused number 01 to 04 follow the instructions of the accused no-05 which are trustees of the said trust & reside outside india. The copy of such complaint is enclosed herewith for your ready reference.

16. That afterwards the said complaint bearing UID number 2268690 was taken up by the o/o DSP NRI WING JALANDHAR. My statement was recorded there & all evidences including screenshots, one pendrive were submitted to the I/o. the url of the accused Id's were also submitted. The complaint was also given to PS NRI WING HOSHIARPUR.

17. That no action is taken by the said officials on my complaint till date.

18. That all accused no- 01 to 05 are habitual offenders and have done several types of offences for which various competent authorities have taken action against them. Such documents proving criminal nature of the accused no-01 to 05 are also being submitted here.

19. That the present court has got jurisdiction to hear and decide the present petition.

20. That the cause of action arose on date 25-07-2023 when the complainant was once again finally came to know that no action is taken on his complaint by the competent authority.

Prayer : It Is Prayed Before This Hon'ble Court In View Of The Fact That accused no-01 to 05 have intentionally, repeatedly and severally gone against the interest of the nation by spreading baseless and highly offensive messages against govt of india and hon'ble prime minister of india. these acts of the accused no 01 to 05 have gone against safety, security, sovereignty of the nation. the accused no 01 to 05 have done their best to disturb the social harmony, peace and public tranquility. so kindly direct the s.h.o police station nri wing hoshiarpur to register fir against accused no 01 to 05 namely Deepak chaudhary, shamsher singh bhardwaj, ashnav sahota, sandeep kumar, & bhagat hari singh charitable trust through its trustees/manager u/s 124-a, 153-a, 505, 121, 500, 501 ipc & 66, 66-a, 66-f of IT act.
