

The detailed expression of opinion is avoided as it is no longer necessary in view of the observation of Hon'ble Supreme Court of India in U.P Pollution Board Versus Mohan Meekan,2000(2) RCR 421 and reiterated recently in Deputy Chief Controller of import and export Versus Roshan Lal Aggarwal, 2003(2) RCR (Crl) 110(SC). Now, the accused be summoned, to face trial under Section 138 of Negotiable Instrument Act, through registered post on filing of RC/AD, PF, copy of complaint, etc., within a week at own responsibility of the complainant, returnable for 19.08.2023. Dasti summons be issued, if so desired.

Satbir Singh vs Balwinder Singh

Present: Complainant with counsel Sh. Deepinder Singh, Advocate.

Arguments heard at length today upon the summoning of the accused. Minute perusal of the file reveals that the complainant and the accused are residing beyond the jurisdiction of this court. However, the cheque in question (Ex.C1/4) was presented in the branch of the complainant bank (Indian Bank) at Sri Anandpur Sahib and the same was dishonoured due to reason "account blocked". Reliance is placed upon case law titled as Jiwan Kumar vs P.A. Terly CRM-M-18600-2015 decided on 01.06.2023 by the Hon'ble P&H High Court and P.S. Raj Steels Private Ltd. Reliance Steel Industries and another CRM-M-46627-2016 (O&M) decided on 13.04.2023 by the Hon'ble P&H High Court. Further reliance is placed upon Section 142 (2) (a) of the Negotiable Instruments Act, 1881 which states as:

The offence under Section 138 shall be inquired into and triec only by a court within whose local jurisdiction-

(a) if the cheque is delivered for collection through an account, the branch of the bank where the payee or holder in due course, as the case may be, maintains the account, is situated

Thus, it is clear from the above discussion that the present complaint is maintainable in its present form as the branch of the complainant bank is situated at Sri Anandpur Sahib.

The other point for consideration is whether the inquiry under
