RESPECTED SIR , PLEASE NOTE AS BELOW :-

THE ACCUSED NUMBER 1 TO 4 ARE RESIDENTS OF LONDON UK WITH ABOVE MENTIONED MOBILE NUMBERS AND THERE ADDRESS IS GIVEN ABOVE.

THE ACCUSED NUMBER 5 IS UNKNOWN HOWEVER I AM HAVING ONE ADDRESS PERTAINING TO HIM AND I SHALL PROVIDE THE SAME TO THE I/O.

ACCUSED NUMBER 6 TO 8 ARE INDIANS WITH ABOVE MENTIONED ADDRESS AND MOBILE NUMBERS & THEY CLAIM TO BE HAVING POWER OF ATTORNEY OF THE SAID TRUST TO DEAL IN VARIOUS GOVT OFFICES.

THE ACCUSED HEREIN MENTIONED ABOVE ARE HAVING A BENT OF MIND AGAINST GOVT OF INDIA. SO THE ACCUSED NUMBER 06 TO 08 POSTED VARIOUS OFFENSIVE POSTS AT SOCIAL MEDIA AGAINST GOVT OF INDIA. THESE POSTS WERE MEANT TO DISTURB PUBLIC PEACE AND TRANQUILITY AND SHOW A HATE AGAINST THE COUNTRY BY THE ACCUSED. I SHALL PROVIDE THE PRINTOUTS OF THE SAID POSTS AGAINST GOVT OF INDIA BY ACCUSED NUMBER 06 TO 08 TO THE I/O. THESE POSTS CLEARLY AMOUNT TO BE AN OFFENCE U/S 153-A IPC , 121 IPC AND OTHERS BY ACCUSED NUMBER 06 TO 08. HOWEVER ALL THIS IS BEING DONE BY THE SAID ACCUSED AT THE INSTRUCTIONS OF ACCUSED NUMBER 01 TO 04 STAYING OUTSIDE INDIA. I SHALL PROVIDE THE EVIDENCES TO THE I/O TO DO THE NEEDFUL.

THERE IS ONE FACEBOOK PAGE OF BHAGAT HARI SINGH CHARITABLE HOSPITAL. HERE THE ACCUSED HAVE DEFAMED AND SHOWN DISRESPECT TOWARDS NATIONAL FLAG OF INDIA AND THEY ARE OVERSEAS CITIZENS. SURPRINSINGLY ENOUGH ON DATE 07-11-2017 AT THIS FACEBOOK PAGE THE ACCUSED WROTE THE MENU OF CHICKEN AND THERE OTHER DISHES TO COLLECT CHARITY.IT IS CONTINUED TILL DATE. SIMILARLY OTHER ONJECTIONABLE POSTS ARE ALSO THERE PUT BY ACCUSED. ALL THOSE PRINTOUTS SHALL BE PRESENTED AND SUBMITTED BEFORE THE I/O.

THE ACCUSED NUMBER 05 NAMELY PARWINDER SINGH NIJJAR CLAIMS TO BE A MEMBER OF THE TRUST IN THE SHAPE OF TRUSTEE. HOWEVER THE DOCUMENT SUBMITTED BY THE TRUST ITSELF IN THE SHAPE OF TRUST DEED SHOWS THAT PARWINDER SINGH NIJJAR IS NOT A TRUSTEE AND HAS NO RELATION WITH THE TRUST. PARWINDER SINGH NIJJAR IS GIVING CLEARLY WRONG INFORMATION TO THE POLICE AND PUBLIC OFFICES WHICH AMOUNTS TO BE AN OFFENCE U/S 182 AND 211 , 195-A IPC AND HE IS DEFAMAING ME AT VARIOUS PLACES WHICH AMOUNTS TO BE AN OFFENCE U/S 499, 500 IPC.

PARWINDER SINGH NIJJAR NEEDS TO BE A TRUSTEE IN INDIA. HE IS OPERATING ANTI-NATIONAL ACTIVITIES BY STAYING OUTSIDE INDIA . I STRONGLY SUGGEST TO TAKE A COMPLETE SECRET REPORT OF THIS PERSON FOR HIS ANTI-NATIONAL ACTIVITIES IN INDIA. PARVINDER SINGH NIJJAR SHOULD BE SUMMONED IN INDIA AND PROBED AND INTEROGATED IN PRESENCE OF THE OFFICERS OF PB POLICE INTELLIGENCE.

I AM AGAIN HIGHLIGHTING THAT PLEASE VERIFY FOR THE ANTI-NATIONAL ACTIVITY OF PARWINDER SINGH NIJJAR AND IT SHOULD BE DONE WITH THE HELP OF PUNJAB POLICE INTELLIGENCE.
